Comments

Poltimore Parish Council note that the site has now been renamed to Wilton Bradley and the road signage to the site has been changed. Wilton Bradley is a company who specialises in the design, development, sourcing, and supply of quality consumer leisure goods. The Council are concerned with the number of large lorries this company will generate onto the already busy Poltimore road with no street lighting or pavement. The site has already got larger than what was once the Equestrian centre with high railings around the perimeter. The public footpath goes across the entrance of the site which could be a risk to pedestrians. The Council would not like to see this site made any larger and develop into a large industrial unit. It would not be in keeping with the Clyst Valley Regional Park.
