- 2. **Hatchland Road potholes**. Cllr D Pritchard to look at plans to see who would be responsible for this.

- 3. **Friends of Poltimore Church**. The Council had received a request to share in the cost of a circular bench to be placed around the Beech Tree in the Churchyard as a commemorate to the 75th Anniversary of VE day 2020.
